Here's Dairis Anucins from the PR Unit of the State Police of Latvia. We had a telephone conversation today. We checked all the contacts in our website. Sorry, really don't know why your fax could not be sent. Fax number and country code are correct. Anyway, here is another fax number. This is the fax number of the Economic Crime Department: +371 67208672 or try 0037167208672.

I also contacted Jelena Kulajeva to clarify this situation. I think maybe it would be easier if I also will give you information in written form

If I understood correctly, you have faced with potential copyright violation that is related with jurisdiction of our state. Sorry for hesitation before, I think you hadn't received correct information about your options.

We are not able to legally interrupt activities of any internet site, before criminal proceedings have been started and proofs obtained. Unfortunately e-mail forms are not acceptable in our legal system to be considered as official information. So, in this situation you're able to send us written and signed application (no special forms required) with adding all materials you have about your case – you are able to send the same information you have sent in e-mail, but with your signature and using postal service. Then procedurally authorised person will make a decision about this case and notice you also in written form. It's the possible way, how to solve this problem.
